## SPECIAL NOTE: Please read this SPECIAL NOTE before filling the form

- 1. The scheme shall commence from 1<sup>st</sup> July 2008 or on attaining membership strength of 1000 whichever is later and membership period shall be from 1<sup>st</sup> April to 31<sup>st</sup> March (12 months in subsequent year of joining).
- 2. A member joining the scheme after 1<sup>st</sup> April will have to pay full amount of admission fee an prorate annual membership fee applicable for the remaining part of the year. (**Example-A** member admitted on 15<sup>th</sup> May 2009 will pay prorate annual membership for ten months, however indemnity cover will be given to him / her from the 1<sup>st</sup> day of the next month of admission i.e. from 1<sup>st</sup> June 2009 to 31<sup>st</sup> March 2010).
- 3. No refund is admissible to any member who wants to discontinue his membership at anytime.
- 4. A discontinued member if he wants to join the Scheme again will be treated as a new member.
- 5. A General Practitioner having his own nursing home and practicing Surgical/Obst./Gynac./Invasive investigational practice will be considered in the category 7A1c for the fee schedule.
- 6. A general Practitioner having Pathological Lab. Or X-ray machine and giving the reports in writing to his patients will be considered in the category 7A1b) of the fee schedule and general medical nursing home facility.
- 7. Continuous membership of Maharashtra State Branch I.M.A. for the entire period of the coverage by the scheme is mandatory.
- 8. For all legal disputes between the member and administration the jurisdiction shall be restricted to the courts at Nagpur Only.
- 9. Members doing MTP must get their Nursing Home / Hospital registered with Government under the MTP act. Similarly members must get registered with all bodies mandatory by law like nursing home registration act, PNDT Act. etc. whenever applicable.
